Annual Church Conference of the Charlton City United Methodist Church Thursday December 3, 2020 7:00 pm

Rev. Stowe opened the evening with a gathering reflection and call to Holy Conferencing

We thank Aleta Dam and Garnet Olson for putting together a beautiful power point presentation for this evening.

Jeanne Kosakowski moved to make this church conference a virtual conference in accordance with the laws of the church. Motion was passed unanimously.

Election of Secretary - Sandy Dam volunteered- all approved

Minutes of the 2019 Church Conference were unanimously approved as written with a Hallelujah.

Audit fund balance report – no questions- unanimously approved

Trustees answered the questions asked by the DS: have we received any bequests or used any capital from investments or endowments for operating expenses or sale of a parsonage? John Hunt answered no to all questions.

Garnet Olson – SPRC – pastor's compensation – 44,900; reimbursable – discussion regarding discrepancy of reimbursable but in the book says 3700 – not sure of why discrepancy- error from a previous year should be 3200 housing exclusion 11,600.

Sandy motioned – to accept compensation, housing exclusion, reimbursable and housing allowance of 14,000 – unanimous

It has been a busy year and the new committee we established was the Right Start Committee.

Finance Report – Nancy Hunt

Current checking balance is \$18,500. Mission shares are 100% paid, current income from pledges has decreased, but the PPP loan has helped with the balance on hand and the insurance payment for the expense for last year's boiler repair has been received as well. Discussion of the budget – finance committee proposing a deficit budget of about \$17,000. Pastor said that he was giving back the housing allowance as part of his family's stewardship so the real deficit is about \$3000. Mission shares may be reduced as the conference budget was lowered. We will check our mission share statement. Motion from the finance committee to approve – unanimous

Lay Leadership report – Pastor John thanked all for taking on the leadership positions. He thanked Danielle and Sandy for taking on the UMW, Jennifer Wheeling who accepted the young ministry coordinator and Amanda Dam for filling in, Kim Constantine for stepping in as the Mission coordinator co-chair, Nancy and Keith Luscombe for agreeing to be Church Council Co Chairs, and Aleta Dam who will be the new membership secretary.

Approval of board of Trustees as printed – unanimous and approval of all leaders – unanimous

Jeanne Kosakowski and Sandy Dam's lay servant reports were reviewed. Jeanne is waiting to hear back from of Overlook as they may have a televised service. She has felt the gift of reading the bible in order to preach – Sandy finished all 8 courses for certified lay speaker – Church approved of continuing as Certified Lay Servant for Jeanne Kosakowski and Sandy Dam as Certified Lay Speaker.

Candidate's report – SPRC voted last month to vote in favor of Sandy going forward into ministry.

Make challenges into opportunities – also Megan DCOM – a vote was taken by poll.

Pastor has never been at a church where any one has been called to become a Local Licensed Pastor.

Being present and part of another's journey is wonderful and after a poll was taken he announced a unanimous decision of Sandy Dam as candidate for Local License Pastor.

Pastors Report – Pastor John would like to thank everyone because it has been a difficult year for a pastoral change with the pandemic and the human sexuality discussion in our denomination and the racial tension in our country. I have nothing but gratitude from me and my family for your welcome and I look forward to meaningful conversations. He highlighted his goals for next year – bible study, concentrate on stewardship and finances and starting neighborhood prayer groups.

Membership Report – Keith and Nancy Luscombe joined but were not listed in the report; they transferred from the West Chelmsford UMC. Megan celebrated the new members and baptisms.

Pastor John remembered Mary Sergel and Beverly Morton and beloved saints. He highlighted that Beverly wanted to join the church and be baptized before she died. He spoke of families that have lost someone and offered a prayer for all.

Rev. Megan Stowe led us in service of communion.

<u>Pastor's Report 2021</u> CCUMC Rev. John H.D. Lucy

Some of us have been waiting and waiting to know what our church will do regarding human sexuality. I have done my best to help us understand the reasons why we might disagree on how to interpret the Bible and the theology and practice that result, and to teach us the principles of holy conferencing. The process has been long and many people are ready to be done. However, after doing some holy conferencing myself with a number of leaders, it seems best to couch our final holy conferencing time on human sexuality within a conversation around our vision for the church generally. Who does God want us to be? Who do we want to be? What's the identity of this church? Since I was planning a conversation on that vision for January anyway, that's when we'll finish. Hopefully that means that we've found our fall time of focusing on restarting ministries meaningful, fruitful, and a means of recreating church unity in our diversity. I will not delay our consensus-making any longer beyond January because I do want us to be able to move forward confidently and with hope about God's plans for us through the turmoil of General Conference and Annual Conference.

Human sexuality has been only one of two major sources of division and anxiety within the church. Perhaps the worst has been the pandemic. No one is completely happy with how we have responded to the pandemic. Some are upset, to say the least. Without rehashing all the arguments and trials we've endured, suffice it to say that working through human sexuality conversations and the pandemic has consumed most of our/my spiritual reserves. It's been a hard year. How do we church in this time? My prayer is that you can join me in gratitude that we have not had any Covid-related deaths within our church family because of actions we have taken. I, for one, am thankful for those of you who have, even while disagreeing with some of our policies, still abided by church decisions to relieve anxiety of those of us worried about the health and safety of our kids who aren't old enough to make health decisions for themselves or get vaccinated.

In the middle of everything, I am further thankful for all the new leaders who have stepped up this year and for next. It's great to see how blessed this church is with God's spiritual gifts. I am thankful for the new members we have welcomed into our church family. I am thankful for YABS beginning to get their hands dirty at Dismas House and Abby's House. I am thankful for those who helped us navigate the PPP loan. I am thankful for those of you interested in starting neighborhood prayer groups. I am thankful for those of you who continue to call and visit one another. I am thankful for those of you who made our worship and ministries possible and fruitful during these challenging times. Basically, I'm thankful for you. Without this church being as faithful, loving, and committed as you are, none of what we've been able to do this past year would have been possible.

What's on tap for next year? I can only speak for myself and what I, at this moment, believe I should focus on as your pastor. Hopefully human sexuality and the pandemic will be less of a drain so that I can work more often with the ministry coordinators to support ongoing and new ministries. I hope to spend more time on stewardship, especially with our new stewardship director, to build on our good work and the workshop the Foundation of the New England Annual Conference put on for us. I plan on expanding my Holy Pastor Doing Stuff retinue to provide resources and connections for the church and community. I believe we are a church uniquely poised not only to continue worshiping and serving God together and supporting one another in deepening our faith lives, not only to continue serving and ministering to those on the margins of society through fellowship, food, and resources, but also to engage with the community to offer our town and surrounding areas new ways to be church, be good, and grow in spirituality and faith. We have the people, gifts, building, and grounds to walk and journey with those envisioning a new future of God's kingdom.

And I look forward to possibly taking the youth and adults to Soul Fest in the summer.

There's a lot more that could be said. These are the highlights. So I say, as always, if you have questions, concerns, disagreements, ideas, or whatever, please do come and chat with me. My door is open, both literally and metaphorically, for holy conferencing.

<u>Worship Team 2021</u>

January through mid-March we offered virtual worship via You Tube; we had some difficulties with technology. We are following the guidelines from the Massachusetts's Department of Public Health and CDC for indoor worship and gatherings. We have a MERV 13 HEPA air ventilation system that is turned on during worship and group meetings. It is highly effective with the required hourly air exchanges and windows are open to provide cross ventilation. Sanitizing guidelines are adhered to. Face masks are required by all who are in our building.

In the middle of March, we resumed in-person worship with 6-foot social distancing between family groups, face masks required. With Pastor John thinking outside the box, we offered drive in Ash Wednesday. We were able to resume indoor Palm Sunday and Easter worship. In June we began to worship in our outdoor Evelyn Hunt Garden Chapel. June through early September we worshipped outdoors unless it was raining. Some additional technology issues are being resolved for livestreaming indoors and outdoors and new outdoor speakers will be needed for next spring/summer. A new portable keyboard for outdoor worship was purchased utilizing memorial funds from Paul Blauvelt who was a beloved choir member. We have eliminated the six-foot distancing in church in September, but the lectern and podium are a safe distance from persons, following public health guidelines.

In June as we began worshipping outdoors, we enhanced worship with more music and in August we began to invite the choir to lead the congregation. Choir members are required to be vaccinated as well as wear a face mask. We are integrating more contemporary music as well adding in special music as we adapt to our new methods. The choir is rehearsing on Thursdays to You Tube and anticipate to soon rehearse with our church musician when the contract is finalized. Our weekly worship attendance is averaging 45 persons. We have returned to utilizing bulletins and the prayer lists for worship, we are grateful to Nancy Hunt, Kevin Hunt, Martha Blodgett, and Nancy Luscombe assisting with this effort.

We have a consistent group of generous persons to usher and greet on a monthly rotation. Others provide reading each week as liturgists. Jean Anderson greets each

week, too, and coordinates our liturgists in addition to providing themed alter decorations. Jean is also playing the keyboard at Sandy Dam's church the George Whitfield UMC in West Brookfield once a month.

Our church musician Jim Perry was being shared with Overlook Chapel the second and fourth Sunday of each month. Jean Anderson and Marion Sergel assisted with our closing music and postlude. We are so blessed to have four musicians in our church. Maria Calkins does our PowerPoint each week, designing and running the program on Sunday. Maria has also volunteered to play on Sundays as a fourth back up to the keyboard. Gary Picard is running the video camera and working to post the worship to You Tube and Facebook Live. Young Adult Bible Study (YABS)

YABS continues to meet every other Thursday at 7pm for an hour to an hour and a half. These meetings serve as an opportunity to fellowship and explore God's word as it pertains to matters young adults face. Our meetings always end with the sharing and discussion of personal concerns and lifting these concerns up in prayer.

YABS kicked off 2021 with a Zoom meeting under the leadership of its new coordinator, Jennifer Wheeling. Even though we were still very much in the throes of Covid and the need to maintain social distancing, the group decided to embark upon a study on neighboring. The thought was that learning to be good neighbors would fill us with hope during a strange time when we were living our days in isolation and not interacting in person with our neighbors—or much of anyone for that matter.

The Art of Neighboring by Jay Pathak & Dan Runyon was the basis of our study. Although not everyone read the book, we still had very good discussions, including how the ideas on neighboring could be carried over to our interactions with others in general and sharing our love of Christ with them. Our study culminated in three of our young adults delivering the message on Pentecost Sunday of what neighboring means to them.

In the early summer YABS shifted to meeting in person at the church—a welcome change for us all!

Early summer was also the time when we began our study on homelessness, which is still taking place at the writing of this report (even though we have taken breaks here and there to focus on other matters, which will be discussed later in the report). We have used the book *Under the Overpass: A Journey of Faith on the Streets of America* by Mike Yankowski as a guide for discussion. The group was overwhelmingly touched by the need of homeless people to simply be regarded as human, to be treated with the respect and kindness that the average person might have for any person who is not hungry, dirty, and living on the streets.

YABS was therefore called to find a way to interact with this marginalized segment of the population and thereby share God's love with then. One of our

young adults found a service opportunity at Dismas House in Worcester, a halfway house for previously incarcerated men. We have now twice taken dinner to and shared an evening meal with the residents there and have plans to do this on an ongoing, regular basis.

YABS has been helping with Worcester Fellowship this year by folding donated socks and filling the lunch bags with the donated food items.

It should be noted that before our homelessness study even began, one of our young adults created an Amazon wish list of items to be distributed to the homeless. Church members have purchased these items, and they have overseen their distribution.

An especially exciting event that has stemmed from our study on homelessness is hosting Matthew Works, a friend of Pastor John, in October. Matthew has been homeless for 26 years and travels all over New England advocating for the homeless, sharing the spoken word, and his message through his artwork. He will be meeting and having dinner with YABS on the evening of Oct. 23 and will speak to the congregation and any visitors from the community after worship service on Oct. 24.

Jim Black joined YABS for a meeting in April to share his knowledge on personal finance and wealth management.

Pastor John attended many meetings this year. During some of these meetings he led discussion of scripture as it pertains to human sexuality. He also answered/continues to answer questions about the future of our church as it pertains to this matter.

YABS produced three issues of its newsletter, *Enlightened*. Topics this year have included immigration, intergenerational relationships, and organ donation.

Members of YABS participated on the CCUMC Athletes team for Open Sky's Friendship Valley Tour in September. It was an opportunity to not only raise money for Open Sky and CCUMC, but to enjoy each other's company.

- ✤ All the volunteers who donated their time and energy for staffing, pricing, cleaning, rearranging, and being the kind face of CCUMC to all who enter
- ✤ Trustees for all the time they spend caring for the church property

Twice Blessed has provided free items to individuals and to the Southbridge United Methodist Church for their Carol's Closet ministry. It has also brought in over \$1600 this year for the church and its missions program.

Staff/Parish Relations

Highlights

- Established protocol for pastoral emergencies.

- Updated contracts for the Musician and Sexton as well as recommended finance set aside funds for our grounds manager. This is currently an unpaid position, done out of love for our church, but we wanted to be able to provide some support for this work if needed.
- Did a more comprehensive review of our Mission and Ministry form which we provide to District annually. In particular, we placed emphasis on our mission statement to discern how it might be more inclusive of all members of our church family.

Mission: To be a Bible-centered community, sharing the Word and our love of Jesus Christ with our neighbors. We envision ourselves as a spiritual hub for the community, growing in faith, sending out disciples, and living our faith in the world. We will review the mission statement again in January 2022 when the pastor initiates further discussion on visioning for our church.

Board of Trustees Report

We had a couple of events in 2021 for the board of Trustees.

Mike Calkins resigned in April as the chairman and Gary Picard was appointed as the Chairman for the remainder of 2021. Kevin Hunt has stayed on as the finance guide for 2021.

All annual inspections of the parsonage and church are up to date including the elevator, the fire alarm system, and board of health. Since the Covid pandemic continues to impact our church, the energy costs have been reduced from less of use of the facility.

The refrigerator died at the parsonage and was replaced. The other appliances, stove, washer and dryer are functioning well. There were some issues with the windows one of which may need replacement. The garage door continues to be an issue and the trustees have recommended replacement. Approximate cost is \$2300. And funds are in the budget for that.

The heating system header was finally repaired by Peterson oil. The new furnace is working well but there was an issue with a sensor for the hot water heater which was repaired. We are in the process of continuing to change out our light bulbs to LED to continue to conserve on electricity and replacing outside lighting for better, safer visibility at night. Jim Hunt has played a large part in overseeing this project.

To improve the visibility of the projector output in the sanctuary, a special paint was added to the section of the wall where the video is viewed. This has improved visibility without the additional cost of a screen or new projector.

After high winds in the spring, the chimney flashing was repaired along with some wind damaged fascia boards.

We lost a longtime church member, Alva Hunt, this year. Through his family requests we have added a prayer labyrinth to the upper level with a pathway leading around the outdoor chapel to the parking lot for easy access. Our church grounds continue to be meticulously cared for and maintained by our trustees and gardener in chief, John Hunt.

In closing I would like to say thank you to everyone for all your effort, care, and love in caring for our church. It has been a privilege to serve as the chair for this ministry. I look forward to continuing to do so over the next year as we come out of this virus interruption to building our church and spreading the love of Christ to our community.

SAFE SANCTUARY POLICY

MISSION STATEMENT

"The one thing I ask of the Lord-the thing I seek most-is to live in the house of the LORD all the days of my life, delighting in the LORD's perfections and meditating in his Temple. For He will conceal me there when troubles come; he will hide me in his sanctuary. He will place me out to reach on a high rock." Psalm 27: 4-5

"And anyone who welcomes a little child like this on my behalf is welcoming me. But if anyone causes one of these little ones who trust in me to lose faith, it would be better for that person to be thrown into the sea with a large millstone tied around the neck."

Matthew 18:5-6

PURPOSE

As a church we are called upon by God to care for and provide a safe place, a sanctuary for our children, youth, and seniors. These people and people of all ages have been entrusted to our care. Our church should be a place where someone can grow in his or her faith and not in fear. This policy and its procedures also protect those who have the responsibilities as leaders and teachers.

In the case of an emergency, an act of nature, fire, or problem with the church building, we need to have documentation of who is in the building and where. This will not only help us but any emergency personnel that may be called to the church.

We are not stating that we have a problem or imply lack of trust; our hope is to protect our children, youth, seniors, our leaders, teachers, and the church body in its entirety. We have set in motion guidelines and documentation to provide a record if an incident should occur.

SCREENING

- 1. Any person wanting to work with our children and youth (18 years and under) will have been a member of our congregation for at least 6 months (a member is someone who attends on a regular basis).
- 2. A CORI request form will be completed by anyone wanting to work with the children and youth for any event.
- 3. Upon return of the CORI inquiry, any offense that involves the safety or reckless endangerment of anyone, or drug use will be denied.
- 4. Any sexual misconduct, sexual offense of any kind will be denied.
- 5. Any offense that involves a minor will be denied.
- 6. Any CORI returned with a negative result other than those mentioned above will be decided on a case by case basis.
- 7. All CORI's will be updated every 3 years and kept for at least 5 years. CORI's will be kept in a locked box. A list of all CORI approved applicants will be compiled and updated as needed.

PROCEDURE

- 1. Registration/Emergency cards and any other paperwork must be completed by a custodial parent/guardian and returned to the Sunday school Superintendent or adult in charge of the activity.
- 2. The Sunday School Wing or place of activity will be checked by an adult before the activity begins.
- 3. Parents/Guardians will need to sign their child in and out of the church for youth and children activities, including Sunday school. Children that are in the 6th grade or older, may sign for themselves with a signed permission slip from their parents. If a sibling is driving a younger sibling, they may sign for the younger sibling with permission from their parent.
- 4. All children will be signed in and out by the person in charge of the activity.
- 5. We will strive to have 2 adults in our Sunday school classes or at each activity involving the children or youth. If 2 adults are not in attendance, the classroom door shall remain open while the class is in session. The Sunday School Superintendent or lay person shall check in periodically.
- 6. All documentation will be kept in a binder on the bookshelf in the Church Office.

REPORTING/INCIDENT REPORT

If an accident or problem should occur involving a minor whether it is a cut, scrape, medical emergency, or allegation of abuse, the following steps will be taken:

- 1. The church will call 911 if the incident is a medical emergency, the parents/guardians if not on site, the person in charge of the activity, and the Pastor.
- 2. A written incident report must be filled out within 24 hours of any situation. If the situation is a type of abuse, step #3 will be taken.
- 3. The Charlton Police Station Department will be notified at [508] 248-2250 and a report will be filed with them. They will guide us as to what forms need to be filed and determine who needs to be notified. This will be done on a case by case basis.
 - a. In the case of a child 17 or younger an 51A report will be filed with the Department of Children and Families.
 - b. In the case of an elder incident a report will be filed with Tri-Valley Elder Services.
- 4. The New England Conference shall be notified of all major incidents [minor cuts & scrapes need not be reported].

All incidents shall be kept confidential

In conclusion, the above steps are in place for the safety of the children and all people involved in any situation whether it be an incident, accident, medical emergency, problem with the building, or disaster.

Children are our present, our future, our hope, our teachers, and our inspiration. As a church it is our duty to provide a safe environment [sanctuary] for them to come to learn, understand, grow, and love God.
